Abstract: This research aims to examine how the values of faith in angels, especially in terms of responsibility, can be applied in more holistic educational practices in the modern era. This research uses a qualitative method with a literature approach. The analysis technique goes through three stages: Data condensation, data presentation, and conclusion drawing. The results of this study show that the implementation of angels' responsibility in carrying out their duties as teachers is very relevant and has a positive impact on the quality of education, both in terms of students' academic results and their character building. Discussion

Faith in Angels

Education is a continuous process, not just for students but also for teachers. Patient teachers understand that they, too, must keep learning and improving. They do not view the obligation to enhance their skills as a burden but as part of their responsibility to provide the best education (Aprianti & Maulia, 2023). Like angels who perform their tasks with unwavering patience,

In the modern era, teachers must recognize that education is dynamic, constantly evolving with new challenges, more effective teaching methods, and the latest learning technologies. Conclusion
